Introduction & Overview **Disruptive Innovation**

The theme "Disruptive Innovation" reflects the acute and complex challenges the Department of Medicine, and healthcare in general, encountered during 2020 and beyond due to the COVID-19 pandemic and other notable events that took place locally, nationally and globally.

Early in 2020, healthcare was thrust into the unknown and uncertainty due to COVID-19 creating a powerful reminder of our multifaceted and changing world. The pandemic had a direct and significant impact on our Department's healthcare delivery in nearly every imaginable way—our patient capacity both ambulatory and inpatient required immediate patient care restructuring and redesign to handle the inpatient surge as well as the down turn of clinic visits and elective procedures, our need to adjust to a change in the workforce, the sudden and untimely loss and death of patients and colleagues, the awareness of adequate and inadequate PPE, the fear and concern of our safety and that of our families, the financial losses, the short and potentially long-term effect of our providers' wellbeing which was being tested and compromised day after day, just to name a few.

As Chair of the largest Department in Hennepin Healthcare, having a strong, well-structured and supportive leadership was invaluable in responding to the many complex operational challenges. I want to recognize and thank our five Vice Chairs, fourteen Division Directors (see page 8), residency program directors, and our department leaders in their system-wide operational roles who innovated during disruption. This department could not have succeeded without the tremendous hard work of our general faculty and advanced practice providers. It became immediately apparent at the start of the pandemic the importance of extensive and timely communication, collaboration, and innovation within the Department of Medicine and throughout the organization at all levels to support our healthcare providers, our trainees, our staff, and our community, to sustain the best healthcare of our patients during this unprecedented time. Many of the HHS leaders are from the Department of Medicine and provided outstanding leadership throughout 2020. These leaders include Dr. Daniel Hoody, Hospital Medicine Division, as interim Chief Medical Officer; Dr. David Hilden, Hospital Medicine Division, as Vice President of Medical Affairs; Dr. Deepti Pandita, General Internal Medicine Division, as Chief Health Information Officer; and Dr. Ajay Israni, Nephrology Division, as President of the Hennepin Healthcare Research Institute. In addition, active members of the HHS Board of Directors and/or HHS Board Committees including Dr. Daniel Hoody, Hospital Medicine Division, on the Audit/Compliance Committee, Finance Committee and Quality Committee; Dr. Gautam Shroff, Cardiology Division, on the Quality Committee; and Drs. Ajay Israni, Nephrology Division, Danielle Robertshaw, General Internal Medicine Division, and Dr. Rachel Silva, General Internal Medicine Division, who served on the Mission

Effectiveness Committee, and I also served on the HHS Board of Directors.

Throughout this report are compelling stories of firsthand experiences as to the impact the pandemic and the civil unrest following the killing of George Floyd had on many at Hennepin Healthcare.

Although the Department encountered numerous challenges and obstacles, we continued to strive to fulfill our mission and vision working diligently to sustain some normalcy, maintain what we had built, and continuing to accomplish so much.

Notably, in 2020, we continued to be successful in our recruitment and hiring of many dedicated physicians and advanced practice providers, we continued to recruit amazing internal medicine resident and fellow trainees. We were successful with the promotion of Dr. Charles Reznikoff to Associate Professor of Medicine as the first faculty on the Master Clinician Track, and the submission of five dossiers for faculty promotions in the Department of Medicine at the University of Minnesota

Medical School. We initiated the Department's Innovation Seed Grant Program to support junior faculty with limited research experience to pursue scholarly activity. We reformatted our Medicine Grand Rounds and Education and Scholarly Forums dedicated to addressing health disparities and health equity, and in an effort to keep education and research in the forefront, we developed the Department's Research Scientist Track for Hennepin Healthcare Research Institute researchers to formally collaborate and integrate within the department. We obtained substantial grant and contract funding, we continued to publish articles at a high rate, and all the while worked to acknowledge, recognize and support our front-line healthcare providers, staff, and trainees.

The Faculty section of the Annual Report starting on Page 9, outlines the Department's new physicians and advanced practice providers. I'd like to acknowledge the appointment of Dr. Gautam Shroff as permanent Director of the Cardiology Division, Dr. Mark LeSage as permanent Director of the Clinical Pharmacology Division, Dr. Michael Rhodes as permanent Director of

the Hospital Medicine Division, and Dr. Jason Baker as permanent Director for Infectious Diseases Division. Clinical

The effects of the COVID pandemic and civil unrest which began the first half of 2020 had material impacts on service utilization which continued through the remainder of the year. Non emergent ambulatory services were paused late first quarter across many specialties and phased reopening of services did not occur until mid-summer or later. Ambulatory services focused on emergent patient care and viral screening while hospital census increased dramatically.




FIG. 2. Trends in Key Funding Sources

Overall Department of Medicine campus based provider ambulatory encounter volumes were flat compared to 2019, but it is worth noting that this is due to 18,419 viral screening visits performed by Department of Medicine providers. Without the addition of these new screening visits, campus based providers volumes saw a decrease in "traditional ambulatory services" of 15.0%. Specialty outreach provider encounters in community clinic settings saw an equal decrease in "traditional ambulatory services" of approximately 11.2%, compared to prior year. (Aggregate ambulatory encounters decreased by 2.6% when compared to prior year, as shown in Figure 1.) Inpatient encounters increased by 4.9% (as shown in Figure 1). There was also a material increase in average length of stay (from 3.80 to 5.13 / 35.0%). Total gross billings from the Department decreased by 3.1%, going from \$89,969,340 in 2019 to \$87,221,459 in 2020 (as shown in Figure 2). This decrease is driven predominantly by the effects of the COVID pandemic and civil unrest on ambulatory based services paused, partially offset by the increase in hospital census and services. In addition, actual aggregate collections saw a decline of almost 3 percentage points / 8.1% when compared to prior year.

In 2020, 82% of the Department's cash revenues came from clinical activities, 10% from service contracts, and

FIG. 1. Provider-Patient Encounters





FIG. 3 Funding Profile

8% from research grants and contracts (as shown in Figure 3). Research grant and contract revenue has been restated from prior years to include revenue transferred into the department to support clinician costs. Total costs awarded for Department of Medicine Research Grants and Contracts was \$29,548,118, which is a 17.1% decrease over prior year, primarily due to material decreases in governmental and industry funded awards in Infectious Disease and Nephrology, partially offset by an increase in governmental funded awards in Addiction Medicine.

The Department's peer-reviewed publications were at record number at 239 and 5 book chapters. The Research and Scholarship section listing the publications begins on page 43 of this report.

Under the directorship of Dr. Rosemary Quirk, the Medical Education Program remained strong during the pandemic and civil unrest in 2020. Our residency and fellowship programs continue to be in high demand. For details of 2020, please refer to the program update and summary starting on page 63.

2020 was not a typical year but one that will be remembered for its "disruptive innovation." I trust that you will find this annual report reflective, interesting and one that demonstrates a department that is strong, committed, and resilient to our mission of clinical care, education and research even during a pandemic.

Incident Command

It was January 23, 2020 and Incident Command was pulled together to discuss what was going on in Wuhan, China. It was initially a smaller group with the Infection Prevention and Emergency Preparedness teams, amongst others. It was still unclear whether or not this was going to be something that we had to be concerned about, but a global pandemic was looking to be more and more likely. We knew that what was making people ill looked like a respiratory virus but didn't know much yet about exactly how it spread and how contagious it would be.

On January 24, 2020, I sent out a communication to the medical staff with an up-to-date guide for providers about the virus and what to do if they suspected a case. A week later, I boarded a plane to Mexico for my annual escape from the winter cold and some R&R. I felt guilty to be leaving for a week with everything going on, but in hindsight I am so glad I did as upon return I was immersed in Incident Command managing the pandemic and have been doing COVID-19 work since.

As Medical Director of both Infection Prevention and Employee Occupational Health and Wellness, I felt this immense internal duty and responsibility to protect both our patients and our staff. I was working around the clock and began reading everything possible in the news and updates from the CDC to always stay one step ahead. Suddenly, I was doing television and news interviews, as well as radio shows with local experts to educate the public and share information. Incident Command rapidly expanded for fast action

and coordinated decision making to include nearly every department in the hospital. I received the title of 'Medical-Technical Specialist' and I became the go-to person for "all things pandemic." The work included guideline and policy writing, operational planning, assisting in developing a Viral Screening Clinic, making decisions about Personal Protective Equipment (PPE) and employee quarantine and travel, collaborating with the laboratory on testing, assisting informatics to build technical tools, answering clinical questions, and more.

While all of that was hard work, one of the most difficult jobs was hearing the frequent anxiety and fear from my colleagues and patients and wanting to ease people's minds while still being straightforward about everything we didn't know in a fast-paced ever-changing landscape.

In hindsight, I realize I somehow had an immense amount of authority that I didn't really know if I was positioned to have, but in a crisis, I think we all just

focus and try to do what is right and worry about the details later. Thankfully, I have a team of incredible and dedicated partners in the Infectious Disease Division who took over my clinic patients and my hospital call weeks for a few months so I could focus all my efforts on the pandemic.

Over the next number of months, we rode the emotional waves which coincided with the viral pandemic waves, as well as tried to make sense of the killing of George Floyd and the violence and trauma to our communities that ensued. These events amplified the pandemic of racism, violence, and the health disparities that exist in minority groups. Our dedicated and incredible staff at Hennepin Healthcare has worked to bridge these gaps with partnerships in the community.

2020 has been both exhilarating and exhausting at the same time, but my ongoing motivation has always been to ensure the safety and wellbeing of my colleagues and our underserved patients. I felt that if we could walk out on the other side of the pandemic and say we didn't lose any of our colleagues, it would be worth every ounce of lost sleep, tears, stress, and hard work. Hennepin Healthcare has been at the forefront in managing the pandemic since the start and I can't begin to say how proud I am to work at an organization that has weathered this global pandemic and cared for our underserved patient population with class, grace, grit, and heart.

Monday, March 16, 2020. We all have days that will forever be imprinted on our lives, and I am sure this will be one of mine (plus, it's just more pleasant to recall than Friday the 13th, our first day-long, full court press of planning the clinic). March 16th is the day we opened Hennepin Healthcare's Downtown Viral Screening Clinic The Viral Screening Clinic (VSC) created a space to safely care for patients coming downtown with symptoms of or exposure to COVID-19 while still being able to continue safe care for everyone else across the main campus too.

I am a primary care doctor and general internist with a strong public health perspective, and I just happened to also be the Medical Director of Hennepin Healthcare's Clinic and Specialty Center (CSC) Internal Medicine Clinic when the COVID-19 pandemic took hold. Working with Infection Prevention, it first seemed that maybe a separated waiting area and partnership with the Internal Medicine Clinic team would be our course for providing care to symptomatic or exposed patients. In short order, however, it became clear that we would need something bigger (ultimately, much bigger). Megan Jorgenson, my leadership dyad as the Practice Manager for Internal Medicine Clinic, and I worked with a team of leaders who represented every part of Hennepin Healthcare on the front lines and behind the scenes. In a matter of days, we designed, put together, and opened the Viral Screening Clinic to fit into the old same-day surgery space that had been unused and empty for the preceding two years.

Day 1 was our first foray into rapid-scale changes with demand quickly exceeding our anticipation, calling on colleagues and friends to help get everyone seen and plan for Day 2. Little did I know, at the end of that 16-hour day, that 73 patients would be a fraction of what we would come to expect and be able to manage while still having a pretty good day! As Minneapolis continued to reel from the impacts of COVID-19 as well as the trauma and distress following the murder of George Floyd, the VSC team rallied for one another and for our community.

The team saw as many as 260 patients on our busiest summer days with visits spilling into the Blue Building courtyard. Rapid-scale changes and "pivoting" became our default as we designed and re-designed workflows, spaces, and teams through the end 2020 (and beyond).

We managed days when the line of patients snaked all the way down the block. We passed out masks and advice and work notes. We gave medications and food bags, arranged rides and isolation hotel stays. We tried to keep people out of the hospital but sometimes had to send them in. We built a "clinic within a clinic" first to do monoclonal antibody infusions and then to kick off COVID-19 vaccinations. We smiled (actually we beamed!) through masks at patients who were still smiling after a two-hour wait. We laughed because something was funny and sometimes just because we were tired. We exchanged gratitude for patience and grace, for listening and caring, and for just being there.

In some ways, with the pandemic ongoing, it's hard to fully reflect on all of the moving pieces, mixed emotions, and other ups-and-downs of 2020. The ultimate "we did it" celebrations are still somewhere

in the future. What I do know now, though, is that while I would never wish for the tragedy the pandemic has been, I'm so thankful for the experience of working with the incredible team that did and supported the work of the VSC and COVID-19 care at Hennepin Healthcare.

Research & Scholarly Activities

Addiction Medicine Division

2020 was a year for the history books for Addiction Medicine. With a busy opioid treatment program, office-based addiction treatment clinic, and consultation services we started the year looking to build our presence in Brooklyn Center and initiate outpatient services of methamphetamine use disorder. March 1, 2020 was the start date for our second 5-year grant from the National Institute on Drug Abuse (NIDA) to support the NorthStar node of the NIDA National Drug Abuse Treatment Clinical Trials Network (CTN). On March 5, 2020, Minnesota reported its first case of COVID-19 and things haven't been the same since.

The demand for addiction services increased in 2020 driven by the pandemic, but also by mass unemployment, stress, political rancor, and the unrest following the murder of George Floyd. Further, many community programs closed under the pressure of COVID-19, forcing patients to seek care elsewhere. The regulatory environment and typical care pathways for addiction medicine required significant reform and innovation to meet this increased demand during a challenging year and Hennepin Healthcare Addiction Medicine rose up to the challenge.

The highly regulated environment of opioid treatment programs requires that many patients come to clinic 6-days per week with minimum attendance at least monthly. In addition to dispensing controlled medications such as methadone and buprenorphine, the Addiction Medicine Clinic engages in individual and group therapy. With the rise of COVID-19, we had a delicate line to balance between safely treating addictions with controlled substances and mitigating the risks of COVID-19.

People with substance use disorders, especially opioid use disorder, are more susceptible to the adverse effects of COVID-19 than those without substance use disorders; yet the very model of treating opioid use disorder through frequent and close contacts potentially placed patients at risk. In addition, the Addiction Medicine staff had to remain on-site in shared offices with little social distancing. Compassion, commitment, and creativity allowed us to maintain services and keep patients and staff safe.

By the end of March, the Addiction Medicine Clinic waiting area had been moved into a tent outside the Shapiro Building and staff checked patients in via laptops. Patients were met at the entrance of the clinic and provided medication. All counseling was delivered over the telephone as staff did not have audiovisual telemedicine resources and most patients lacked devices with sufficient bandwidth for telemedicine. Meanwhile, the clinic examination and group therapy rooms were transformed into staff offices to allow for social distancing and the clinic space was reconfigured

to allow a steady yet small flow of patients through the clinic. The office-based clinic used telemedicine when possible but a significant number of patients receive injectable medications requiring in-person visits. While the consultation service saw an initial dip in requests during the first two months of the pandemic, volume soon returned to prepandemic levels.

Rising to the challenges of COVID-19 required teamwork across the Hennepin Healthcare community. Community donations of PPE for the 600 plus patients who came regularly to our clinic was greatly appreciated. Facilities Management installed an awning outside of our clinic so patients would not be rained on during inclement weather. Infection Control reviewed our space and workflow, frequency helping us revise practices as knowledge of the virus evolved. The volunteers of the Hennepin Healthcare Foundation provided morale boosting sidewalk murals and treats to our staff. Information

Technology acquisition of iPads and telemedicine licenses prevented interruptions in care. And the Addiction Medicine staff stepping up to deliver necessary medication to patients in quarantine kept patients safe from both the risk of overdose and the risks of COVID-19.

Fortunately, there were few interruptions to our research and educational endeavors. Our collaboration with the University of Minnesota's Dr. Kelvin Lim to evaluate the effect of direct current transcranial stimulation and cognitive training on opioid relapse was suspended temporarily due to the needs for social distancing. Two national multi-site studies on treating opioid use disorder in hospital settings (CTN-0098A and CTN-0098B) were delayed in roll out as research staff could not access overwhelmed hospitals. Our multisite trial of a clinical decision support tool for primary care providers addressing opioid use

disorder (CTN-0095) was delayed as many primary care clinics transformed into COVID testing sites or to telemedicine practices. However, we also found new opportunity to study the effect of COVID-19 regulatory changes in opioid treatment programs on patient drug use (independent analysis and CTN-0112). The Addiction Medicine fellows continued to rotate and engage patients through telemedicine or fully garbed in PPE during inpatient consultations. Our ongoing state-funded Integrated Opioid and Addiction Care ECHO tele-learning community didn't miss a beat and quickly provided a statewide forum to learn about the treatment of opioid use disorder in the time of COVID-19.

By the end of 2020, our staff were exhausted but had successfully adapted to the demands of addiction care in the era of COVID-19. Due to their hard work,

and despite the increased risks faced by those with substance use disorders, COVID cases in addiction medicine mirrored those in the general community.

While no one wants to see COVID-19 as the "new normal" in 2021, the Addiction Medicine staff entered the New Year knowing that they faced one of the greatest crises of the past 100 years with excellence, compassion, and teamwork.

The Infectious Diseases (ID) research program includes four principal investigators, Jason Baker, M.D., M.S., FIDSA, Kristina Burrack, Ph.D., Anne Frosch, M.D., M.P.H., and Keith Henry, M.D., along with over 12 research staff and additional students. The group's research is broadly focused on infectious diseases that disproportionately affect the community served by Hennepin Healthcare, involving approaches that span immunology, disease pathogenesis, translational intervention studies, and large-scale clinical outcome trials. Prior to COVID-19, the ID research portfolio included studies of HIV prevention and treatment, HIV-related inflammation and cardiovascular disease, and the immunology of effective and pathogenic host response.

In response to COVID-19, the ID Division launched the Program for Immune Therapy and Immunology. Through this initiative, the group conducted numerous NIH and industry funded clinical trials and launched an observational cohort to characterize immune responses and cardiac complications of COVID-19. During the first year of the pandemic, the ID program enrolled over 200 patients into COVID-19 treatment studies and 140 patients into the COVID-19 observational cohort.

Among approximately \$2.5M in research awards received by the ID group during 2020 (12 new awards and 8 renewals), \$1.4M was specific to COVID-19 research (11 new awards) with most of these projects extending into 2021. This new COVID-19 research portfolio also supported research staff from five different programs at HHRI, when projects in those labs had to be temporarily paused. The programs for each of the four ID investigators are summarized below.

Dr. Jason Baker directs a clinical research program focused on immune mediated complications in context of

HIV disease or COVID-19 (funding via NIAID, NHLBI, NIA, NIDA, NIMH and industry). A central theme in this program over the past decade has been the pathogenesis of HIV associated cardiovascular disease. This included testing intervention strategies to reduce chronic inflammation and coagulation activation among persons with HIV. In recent years, Dr. Baker established a collaboration with investigators at the University of Cape Town in South Africa (Dr. Mpiko Ntsekhe), where they are studying the influence of chronic HIV disease on myocardial fibrosis and the implications for heart failure risk.

In response to COVID-19 pandemic, Dr. Baker conducted numerous clinical trials among hospitalized patients with severe COVID-19. These included two adaptive multi-stage trials conducted through the NIH Accelerating COVID-10 Therapeutic Interventions and Vaccines 3 (ACTIV) initiative.

ACTIV-3 was focused on anti-viral strategies, and initially tested monoclonal antibodies, with ACTIV-5 focusing on immunomodulatory strategies. Dr. Baker


also led two industry trials that studied the antiviral drug remdesivir (Gilead Sciences) and the anti-GM-CSF inhibitor lenzilumab (Humanigen, Inc.); both agents subsequently demonstrated a positive treatment effect among hospitalized patients. Moving forward, Dr. Baker is protocol chair for an outpatient trial of anti-SARS-CoV-2 IVIG and developing a focus on the immunology of COVID-related cardiac injury, which represents an area of overlap with his HIV research.

In addition to serving on the Hennepin Healthcare Research Institute Operations Committee and Board of Directors, Dr. Baker is a member of the U.S. DHHS Panel on Guidelines for the Use of Antiretroviral Agents in Adults and Adolescents with HIV, and the NIH Panel on Coronavirus Disease 2019 (COVID-19) Treatment Guidelines.

Dr. Kristina Burrack's Lab has a central goal to develop a comprehensive understanding of hostpathogen interactions in order to enhance immunity and limit immune-mediated pathology, with a focus on the pathogenesis of malaria and other pathogens of global health importance.

The Burrack Lab combines translational research and animal models of Plasmodium infection to investigate the host immune response to malaria. This includes defining immunological mechanisms that promote parasite clearance without causing pathology. Specifically, interactions between innate and adaptive immune cells during Plasmodium infection, with a focus on natural killer (NK) cells and T cells. Overall, the Burrack Lab seeks to improve our knowledge of the immune response to Plasmodium infection, which will inform the development of host-targeted therapeutics and vaccines to promote an effective immune response.

As a result of the COVID-19 pandemic, the Burrack Lab pivoted to assist the ID research group with developing

and implementing laboratory components of COVID-19-related research, including blood and cell processing and development of an COVID-19 antibody assay. During this time, malaria research was put on hold for several months, but has since restarted with support from COVID-relief funding and multiple new grant applications to be submitted in 2021.

Dr. Anne Frosch's Lab is based in translational immunology focused on T and B cell responses to infections and vaccines.

She currently has NIH funding to track vaccine specific immune responses in humans using specialized techniques that are most commonly used in animal models. She is also conducting a clinical trial of iron supplementation for children with HIV, specifically examining how this treatment affects immune activation and vulnerability to other infections. The long-term aim of her research program is to understand how chronic infections and diseases affect critical parts of human adaptive immunity. Recent publications have described the influence of HIV on B-cell immunity to malaria and the influence of recurrent infection on CD4+ T-cell

immunity (PMID: 31470903, 28526680, 32983171). Dr. Frosch has a specific clinical interest in malaria immunology, and has used her research expertise to advocate for access to affordable malaria treatment and prevention for our patients.

During the pandemic, the Frosch Lab led the initiative to offer COVID Convalescent Plasma (CCP) through expanded access and also supported the effort to offer COVID-19 therapies through the NIH/ACTIV clinical trials. Dr. Frosch also implemented and maintained the COVID observational cohort, and is characterizing immune responses to SARS-CoV-2 over time to better understand how patient-specific factors affect long-term protection from the virus.

Dr. W. Keith Henry's clinical research program focuses on evaluation of novel antiretroviral treatment strategies for persons living with HIV, with a focus on safer and more effective options including efforts to improve equity in access and outcomes (i.e. studies that enroll only African-Americans [both native and foreign born], women, or persons with advanced renal failure).

Of particular interest has been the development of new drugs active against resistance virus and/or that have fewer long-term metabolic side effects. Dr. Henry's group has participated in the key registrational trials for most of the new HIV drugs over the last several decades. Recently, this has included highimpact clinical trials utilizing long-acting injectable HIV medications leading to FDA approval of Cabenuva[©] (LA formulation of cabotegravir-rilpivirine). A sentinel HIV prevention trial recently completed was DISCOVER, which evaluated tenofovir alafenamide-emtricitabine; results to be published in 2021 in Lancet HIV (Dr. Henry was a co-author).

The COVID-19 pandemic had a major impact on Dr. Henry's clinical research program with no new studies opening for approximately 18 months (to be resumed in 2021, with new HIV drugs of high interest islatravir and lenacapavir). Restrictions on campus required that research staff work remotely and/or reduce hours. It took considerable imagination and flexibility on the part of research staff to continue participant engagement and study data collection during this time, and to the credit of the program no

research subject dropped out or missed key study visits (including patients with IM injections) associated with Dr. Henry's HIV protocols.

Moving forward: During 2020, Infectious Diseases investigators pivoted toward the COVID-19 pandemic in response to the community and institutional needs. This necessitated innovative approaches to start new research, strengthened the interconnectedness of our Infectious Diseases programs, and built new collaborations.

In particular, our group is grateful for the collaboration with colleagues across HHRI/HHS and the institutional support and investments that guided us through 2020. As a result, the breadth and focus of Infectious Diseases research at Hennepin Healthcare has now expanded and we are optimistic that our programs will continue to grow and respond to the community we serve.

Educational Activites



Medical Education Program

Internal Medicine and Emergency Medicine-Internal Medicine (EM-IM) residents braved the arrival and surges of COVID in 2020, courageously caring for essential workers, immigrants, frail elderly and other vulnerable members of our community. Residents learned the complex pathophysiology and complications of the highly transmissible coronavirus by providing direct care to many patients and engaging in discussions with faculty experts and mentors. They mastered virtual family conferences, attended virtual lectures and Teams meetings, and learned the basics of telemedicine. In summer, in-person (socially distanced) Morning Report and Friday School returned, new interns arrived, and longstanding teaching conferences (Chest-ID, Clinical Cardiology) resumed in RL-110. In December, residents lined up for the Pfizer vaccine. Their resilience in difficult times cannot be overstated. Hennepin residents are defined by their courage, curiosity, willingness to help others, and ability to take ownership over the problems at hand, no matter how frightening or daunting.

Michelle Herbers, Nina Setala, program faculty and residents designed and implemented a virtual interview season in 2020, which allowed us to meet 30% more applicants in the midst of the pandemic. It was a true team effort. Michelle built a new recruitment website, PGY3 Josh Degallier created a short film entitled A Day in the Life of an Internal Medicine Resident to showcase our facilities, didactics and multidisciplinary rounds, and Associate Program Director (APD) Michael Lawson organized and filmed faculty describing unique aspects of our program. We highlighted our

Global Health and Primary Care pathways, Butterfly Ultrasound program, research infrastructure, wellness and population health initiatives, immersion activities and integrative medicine mentorship. Chief Residents hosted virtual gatherings prior to interview days and coordinated resident involvement in the recruitment process. We received rave reviews from applicants about their experience, and were beyond happy with our Match results: the 2021-22 intern class is academically exceptional, with 40% underrepresented in medicine, the most in our history.

The Class of 2021 and Chief Residents, who served valiantly during the pandemic, also achieved and thrived academically.

Twelve matched into fellowships in Cardiology, Pulmonary-Critical Care, Gastroenterology, Endocrinology, Nephrology, Rheumatology, Geriatric Medicine and Critical Care. Over half published during training. Eleven became hospitalists at the University of Minnesota, Hennepin, North Memorial, Fairview Ridges, Methodist, St. Mary's Medical Center in Duluth, Mercy Hospital in Iowa and Legacy Emanuel in Portland, Oregon. Two joined Mayo Clinic primary care practices in Redwing and Austin.

One of our programmatic goals is to expand Hennepin's rural footprint and impact; we are ecstatic four graduates have taken jobs in rural Minnesota communities in recent years, where they will provide exceptional care with compassion and kindness to underserved rural people.

George Floyd was killed in May of 2020. Residents had met and cared for George in the months before his death, and remembered him as a kind man juggling multiple jobs who had come to Minnesota to start a new life. In response to his death, Hennepin Healthcare laser-focused its efforts on equity, hiring a new Chief Equity Officer and adding additional diverse leaders to the highest levels of the organization. The Department of Medicine devoted its 2020-2021 Grand Rounds series to Disparities in Medicine, bringing incredible virtual speakers to Hennepin, while Internal Medicine and EM-IM residents formed an Internal Medicine Diversity Committee and helped create a pathway to Chief Residency for residents on J-1 visas. Dr. Anne Becker, Director of Faculty Development for Medicine Education, taught bystander training to all residents to help them recognize and combat discrimination faced by peers, nurses and other employees of color in the workplace. She also facilitated 18 Race in Medical Education Journal Clubs for faculty to help them identify biases, effectively manage racist patients, and better support learners who experience racism at work.





New Innovations

Creative Telemedicine Solutions Powered by Data

It was a Friday afternoon in March 2020. The scope of the pandemic was just starting to emerge, and everyone was rapidly trying to adjust to the new reality of practicing medicine with limited physical contact. At Hennepin Healthcare, like most other healthcare delivery organizations in the country, we had decided to shut down all our ambulatory services and decided to rapidly transfer almost 100% of our in-person outpatient care to Synchronous Telemedicine (telephone or video) and also scale up our Asynchronous Telemedicine services (E visits and Store and Forward). We had a sense of urgency around this rapid deployment.

I remember being in meetings for days sometimes for over 12 hours along with the Department of Information System and Technology (IS&T) Informatics teams to determine the best path forward. We were able to scale up our E-visit offerings within 72 hours of the shut down and offer full spectrum Video visits within three weeks, a process that would have normally taken over three years. It was not just a technology marvel to pull this off in such a short time line but also speaks volumes to the grit and determination of the team members who understood what it meant for our patients to stay connected to their providers and teams. Once we were able to test and deploy Telemedicine offerings we then did a phased approach starting with the highest need clinical areas first and eventually going down the list to ancillary services such as Therapies, Nutrition Services, etc., and today almost every clinical service offering has the capability of being provided over Telemedicine if the service areas chooses to do so.

With the pandemic we saw a mushrooming of Telemedicine services. Data nationally suggests that up to 70% of health systems scaled up Telemedicine services in one form or another. The gains were not only in terms of avoiding exposures by limiting patients coming into clinics and hospitals but also helped conserve PPE. This was also supported by loosening of the regulations around telemedicine and realignment of government and commercial payers to support reimbursement for these services at par with face-to-face visits.

As you can imagine, Hennepin Healthcare scaled up telehealth at a rapid pace, but what we learned over time is that standing up telehealth from an IT standpoint is the easy part; adoption by diverse populations is an entirely different challenge driven by a myriad of factors. The end result is a divide in terms of equity of access to healthcare for certain communities. Was telemedicine truly solving the challenge of access to care for our entire patient population? In fact, the concern was that it was making the gap worse. We went back to the drawing board. Telemedicine visit volumes were already a key performance metric for us, but we had never stratified those metrics by race, ethnicity, or language,

yet alone more nuanced metrics such as information about income, housing stability, clinical risk, and others. Our analytics team worked with our informatics team to define and add stratifications for certain population groups, so we could really understand who was using and benefiting from our services. Data can be powerful when it allows a new story to emerge, and this was a story that we had not truly examined before.

At the beginning, subdividing our metrics in this way added work for our analytics team, a tall order when the team was already stressed with reporting needs relating to the pandemic.

When our operational leaders were presented with data in a way that was simple, powerful, and consumable, that resulted in true aha moments that drove change.

For example, there was a prevailing assumption that Latinx patients were low utilizers of telemedicine generally, but the data showed that younger patients were much more likely to engage. There was speculation that this was due to a lack of access to enabling technology in the older population, but a community needs survey revealed a much simpler problem: those patients were less likely to be proficient in English. Updating our telemedicine tools and outreach to support Spanish speakers resulted in a jump to 80% utilization, and it transformed the medical director of the clinic from a critic of telemedicine to one of our strongest advocates.

Thankfully, the story that the data told us was not too alarming. While gaps were uncovered, they were not nearly as drastic as was feared, and armed with data, we had a better understanding of the populations that needed more targeted and culturally aware outreach.

The experience of recognizing the blind spot in our data illustrated a larger concept: the need to raise that awareness across all of clinical and performance metrics. We adjusted our approach to be more deliberate, and now every time a reporting need is identified, those reports are stratified, as a matter

of course, along race, ethnicity, gender, and age.

Moreover, we added pre-built populations to the data explorer tools that our physicians use, so that they too can understand if and where disparities exist across their patients.

Once we began showing these stratified metrics to our operational leads, executive teams recognized the power of data to drive our strategic direction. Thus, equity has become, not a standalone goal in its own right, but layered into every other strategic goal, be it financial, clinical, or operational.

The data also empowered our team to get creative in finding solutions. We created a custom code to translate messages via text to log into zoom into Spanish and Somali. We further leveraged this technology to do outreach with vaccines later on. We developed instructional videos in multiple languages for patients to be empowered to leverage Telemedicine. We had initially launched our Video visits to just launch via MyChart which is an English-only medium so we again did some local innovation and enabled patients to be able to do visits outside of MyChart.

The Telemedicine journey has been one of iteration, innovation, intrigue and there have been numerous learnings along the way. The most gratifying part is how our patients have stepped up and embraced this

new way of getting care. Our patient experience scores are consistently higher for Virtual care compared to face-to-face. We also have been deliberate in balancing the equity side of Telemedicine and using it as a tool to bridge gaps in equitable care as evidenced by our data rather than create a larger digital divide. We are continuously advocating for Telemedicine as a sustainable care delivery tool and as evidenced by our recent win at the Minnesota legislature our advocacy efforts paid off and we will continue to get reimbursed at same rate as face-to-face care for both audio only and audio/video visits.

While we went full steam ahead and scaled from a zero Telemedicine footprint to a sustainable viable model, much still needs to be done. A traditional and systematic approach has to be evolved incorporating activities such as strategy development, needs assessment, business cases and plans, readiness assessment, implementation plans, change management interventions, and ongoing monitoring and evaluation. Only then can we have a successful telemedicine service that is integrated into everyday clinical practice.

Project ECHO and the National Nursing Home COVID-19 Action Network

The Department of Medicine was one of hundreds of ECHO training centers that participated in the National Nursing Home COVID-19 Action Network. This national program reached over 9000 nursing homes across the U.S. with the objective of facilitating best practices for COVID-19. November 2020 was the beginning of what would become the largest surge in COVID-19 cases in Minnesota. Deaths in skilled nursing facilities rose relentlessly starting in November through the early winter months until the effects of the vaccines, available at the end of December, took hold. It was at this moment, November 9, 2020, that Hennepin Healthcare began a series of interactive, virtual learning sessions using ECHO methodology with curriculum tailored to the staff of skilled nursing facilities.

ECHO methodology is not designed as a webinar to present information. It is a series of virtual sessions involving a closed cohort of participants. The sessions create a safe forum for presenting curriculum, discussing clinical cases, and building consensus about best practices. The philosophy of "all teach, all learn" proved valuable during a time of uncertainty at the height of the pandemic.

Supported by the federal Agency for Healthcare Research and Quality (AHRQ), and in collaboration with the Institute for Healthcare Improvement (IHI) and Project ECHO at the University of New Mexico, the Hennepin training center collaborated with the University of Minnesota ECHO training center. This collaboration resulted in coordinated recruitment of nursing home participants, standardized curriculum

between the two centers and shared subject matter experts. Topics included infection prevention strategies such as surveillance and testing, as well as management of illness. The curriculum addressed nursing home staff burn-out and workforce shortages.

Nearly three-quarters of the skilled nursing facilities in Minnesota participated in the nursing home ECHO. The program was presented in weekly 90 minute sessions as funded by AHRQ, through August 31, 2021. Over 100 weekly sessions were presented by facilitators Roberta Meyers and Gregory Leierwood from the Department of Medicine with coordination provided by Deanna Bauer. The ECHO continues today with twice monthly sessions, rebranded as the Minnesota Geriatrics ECHO. A core group of interested participants share their experiences and continue to provide one another support as the pandemic persists.

The innovations key to the success of the program include the use of ECHO methodology, the ability to tailor session content and curriculum to real-life, current challenges faced by skilled nursing facility staff, and the collaboration with the University of Minnesota.

Plans are to continue the Minnesota Geriatric ECHO because of the ongoing interest of the participants and the effectiveness of the "all teach, all learn" philosophy in developing best practices in skilled nursing facilities.
